## **Communications from the Council:**

#### **Recommendations/Procedures for Re-Naming Streets**

5. To: City Council

We believe that having a large number of our City Streets re-named, diminishes any distinction bestowed to those honorees.

In order to make a determination on the appropriateness of a street being re-named this Committee recommends the following:

- \*\*Any request made to the City or this Council to re-name a street would be sent to this Committee to review, and this Committee would then send a recommendation to the Council for Approval or Disapproval
- \*\*Any re-naming is approved by the Council, it would only be Honorary for that person or group indentified. The current name of our streets will always remain, unless so deemed by the Council

- \*\*There needs to be evidence of support by one or more geographically relevant civic groups or associations.
- \*\*Evidence of support by local businesses or other entities (e.g. schools, churches, etc.) on the street that might be affected by the re-naming
- \*\*Statement why the candidate(s) is/are historically or culturally significant
- \*\*A map showing the exact geographic limits of the re-naming requests
- \*\*A petition signed by local residents with the number of signatures proportionate to the length/section of the street proposed to be re-named
- \*\*Any request, needs to be submitted with the above criteria and application included to the City Clerk. Also, with this application a check made payable to the City of Lackawanna for \$200.00.

\$100.00 is a non-refundable processing fee and the other \$100.00 will pay for the

"Honorary" street sign and installation that would accompany the already existing sign.

If the street name is denied, only the check for the sign costs will be returned to the petitioner. The \$100.00 processing fee is not returned.

#### **Commercial/Residential Conversion Process**

7. To: City Council

I have noticed a building permit was issued at 118 Ridge Road. This is the former Ridge Dental Arts building. As I understand it, the building is being converted to residential.

If that is true, my question is, in order for this to occur does this require zoning or planning board approval and did this particular property come before the zoning or planning board for approval? If this does not require any approval from any board, I would like to request an ordinance be prepared requiring planning and zoning board approval to convert a commercial or mixed-use (non-homestead) property to purely (homestead) residential. I would also like the ordinance to include an application process and a non-refundable fee to file the application. The ordinance should also indicate that no such work should be permitted on any property to make the conversion until it has received proper approval from the planning and/or zoning board. Lastly, I would like the ordinance to contain a clause outlining exact consequences for beginning work without consent from the appropriate board(s).

Additionally, I would request going forward that the Council be notified immediately once any applications have been filed with the Development office for such a conversion.

## **Survey-FTE/PTE-Lackawanna Businesses**

10. To: City Council

At the council meeting on January 14, 2016 and again March 19, 2016 I requested the feasibility of a survey to Lackawanna taxpaying businesses requesting the number of PTE as well as FTE that actually reside in the City of Lackawanna.

Below is an excerpt:

Would it be possible / feasible to draft a survey to all Lackawanna taxpaying businesses requesting the number of PTE and FTE that reside in the City of Lackawanna?

I ask for several reasons, the first being that the economy of our City can benefit from having citizens who work here that live here. The second would be to determine if consideration of some type of local benefits that might entice businesses that open here to hire citizens of Lackawanna. There are plenty of qualified bodies that are unemployed or might be willing to take a second job if it were close to home. We may be able to entice a business to hire our citizens with small, localized incentives. The folks that I employ that reside in Lackawanna (29) own homes, pay taxes, and patronize varieties of different business in Lackawanna. In other words, it is beneficial because it helps keep our local economy moving.

I was provided a copy of a "draft" survey by the DOD prior but there was never any action taken. I asked the Director of Development if he have access to this survey. If not, can we please

discuss a new one to send to our businesses to obtain the data necessary to determine if such a program might help our citizens and local economy. It should be noted that I would like to include any benefit that may come of this to include the businesses that currently exist.

# **Procedures/Timeframe Suggestions for Re-Naming Streets**

12. To: City Council

Over the past couple of years several members of the community have come to the Council to request to have a street co-named for a loved one or someone important in their lives. This is an incredible honor and the Council has stated several times that we would like to have guidelines under which to select individuals deemed worthy of such an honor.

In order to make a determination on the appropriateness of a street co-naming request, I would like to propose the following:

- The street being requested for co-naming and a map showing the exact geographical limits of the co-naming request
- Individuals who are deceased for at least three years
- Lackawanna residents or natives or individuals of particular importance to the City of Lackawanna
- Individuals or groups of enduring or lasting interest to large segments of the city's population or those who have undertaken an act or acts of enduring or lasting interest to their community
- Individuals or groups with historic value to the city
- Individuals or groups whose importance to the city or whose enduring interest is a result of exemplary acts or achievements which reflect positively on the city
- Evidence of support by local businesses or other entities (e.g. schools, churches, etc.) on the street that might be affected by the co-naming
- A statement why the candidate(s) is/are historically or culturally significant
- Petition signed by local residents, with the number of signatories proportionate to the length/section of the street proposed to be co-named
- Evidence of support by local elected officials

### **Procedure and Timeframe**

Street co-naming is made by an act of legislation. I firmly believe that large numbers of street co-naming diminish the distinction given to those we choose to honor. Therefore, I would like to suggest that the Council only reviews applications for co-naming once every 7 years. No more than one street should be co-named each 7 year period. If no candidate is deemed to meet the requirements, the Council may choose not to co-name a street in any given 7 year period.

The period for submitting requests should be March 31st - April 30th in the year commencing the 7 year period. It is the responsibility of the proposer to leave sufficient time for the numerous steps necessary before a request is included in legislation. The clerk will advertise for street conaming at least one week prior to March 31st and no more than 7 first come-first served applications will be considered. In the event some are disqualified, the next in line after the 7<sup>th</sup> should be considered in order of submission.

All street co-naming requests would be submitted to the Clerk's office prior to April 30th and a 30 day vetting period will commence to ensure accuracy and honesty on applications. A volunteer committee should be assembled by the Council with each Council Member appointing a member from their ward to undertake the vetting process. The Council President would be required to be on the vetting board. Appointed members of the vetting board cannot be employees of the City of Lackawanna, may not be elected officials, and may not be serving on any other board. This would be a total of five members, 4 residents, each from a different ward, and an elected official (Council President). Any untrue or false statements made on an application will result in disqualification for consideration. The board will present its findings to Council and will submit no more than 3 names to the Council for final consideration. The Council will have 30 days to consider the candidates before voting.
