# **Budget Message-2017-2018**

7. To: City Council

I am submitting to you the proposed budget for the City of Lackawanna. The most notable differences in this year's budget are the increase in police officers. As we are financially preparing for the retirements of officers who fall under old contract rules, we must also prepare for the retirement and loss of service to our police force. We are also preparing a new line item for departments for necessary equipment purchases. As our fleet is aging in numerous departments, we are preparing for future purchases of fire, DPW, and police equipment and we are setting \$255,000 aside for these necessary purchases. I believe this is a good, new, change that will allow departments to continue to pull from this pot and keep our fleets in working order.

It should be noted that the police and fire department's contracts expire at the end of July, 2017.

The police contracts, prior to 1997, has allowed for an unlimited accrual of various benefits which are paid at the time of retirement. Every year we are obligated to ask the department chiefs to canvass their work force and see who is contemplating retirement. Last year we funded almost a half a million dollars in preparation for police retirements, since those retirement haven't happened, we are allocating \$419,000 in special reserve account for these police retirements. Also, \$4,500,000 is now budgeted for health care for both, the operating and the special revenue-refuse budgets.

As the city council has requested to have meetings with departments to address their requests for the budget, I have reviewed their requests and have made additional changes. I have reduced the department head's requested budget by over \$686,411.

The New York State phony 2% tax cap is once again below 2%, it is 1.36%, and as with so many other communities throughout New York State this year, the city's property tax cap will have to be voted on to be overridden. This submitted budget is 0.07% over the allowable 1.36% tax cap, for a total of 1.43% increase. If it was a true 2% tax cap, we would be under the tax cap and not have to waive it. We continue to be under New York State's constitutional tax limit.

New York school districts have received increased state aid every year; New York State AIM (Aid and Incentive for Municipalities) has not increased for local governments since 2008.

The garbage user fee is no longer subsidized by the general operating budget and is now fully self sufficient. In order to remain financially viable in future years it was agreed upon that his fund must remain fully self funded. This year's annual garbage fee is lower than last year's fee.

As you are aware, I am only allowed to submit a 0% tax shift. Since the budget to the city council does not have a unified rate, like most surrounding communities, the formula has left a heavy burden on businesses. At the end of each budget, I submit viable options of rate shifts. Due to the continued severe difference between the homestead and non-homestead tax rates, I would support a vote in order to help offset the costs on businesses.

**SECTION 1.** That the 2016-2017 Budget Ordinance adopted June 16, 2016 is hereby amended to transfer appropriations for decreasing salary of Recreation Director and increasing salary of Clerk position

# AN ORDINANCE ADOPTING THE CURRENT EXPENSE BUDGET OF THE CIT OF LACKAWANNA FOR THE FISCAL YEAR 2017-2018

**BE IT ENACTED** by the City Council of the City of Lackawanna, New York as follows:

- **SECTION 1.** The City Charter of the City of Lackawanna, New York requires that the City Council, at a meeting thereof, held not later than the 10<sup>th</sup> day of June, adopt a Current Expense Budget for the fiscal year, August 1, 2017 through July 31, 2018, showing all City expenditures and revenues and including the real property tax rate.
- **SECTION 2.** That the sum of \$10,754,008.00, being the entire amount determined to be necessary to be raised by taxation to defray the expense of the City for the 2017-2018 fiscal year, apportioned in the amount of \$5,787,734.00 for properties qualifying as homestead properties and \$4,966,274.00 for non-homestead properties, in accordance with the detailed statement of revenues and expenses as estimated and adopted by the City Council, be and the same is hereby levied upon all real and personal property subject to taxation upon the assessment roll of the City of Lackawanna for the 2017-2018 fiscal year.
- **SECTION 3.** That the City Clerk be and hereby is directed to extend and apportion the said sum levied and to be raised by taxation as aforesaid in the last assessment roll of the City of Lackawanna delivered to him and to deliver a certified duplicate of the same, with a warrant annexed, under the seal of the City of Lackawanna, to the City Treasurer, commanding her to receive, levy and collect the several sums in said roll specified as assessed against the persons or property therein mentioned or described with such percentage in the manner provided by law for the collection and levying of City taxes by the City Treasurer.

**SECTION 4.** That the following schedule be and the same is hereby adopted as the Current Expense Budget of the City of Lackawanna for the fiscal year August 1, 2017 through July 31, 2018 along with the revenues and taxation estimated and levied herein, and that same be and hereby is appropriated in the sums set forth in the third column of said schedule to the use of several boards, departments and offices for the purpose enumerated therein, to wit:

Homestead Tax Rate: \$16.95 of assessed valuation Non-Homestead Tax: \$37.60 of assessed valuation

**SECTION 5.** That the City Clerk be and he hereby is directed to forward a copy of this Ordinance to the City Treasurer, Director of Administration and Finances, City Comptroller and the City Attorney's Office. **THIS ORDINANCE SHALL TAKE EFFECT IMMEDIATELY**
