Section 75-11A. Fire safety and property maintenance inspection is hereby rescinded and replaced as follows:

- A. (1) Fire safety and property maintenance inspections of buildings or structures which contain an area of public assembly shall be performed at least once every 36 months
 - (2) Fire safety and property maintenance inspections of building or structures being occupied as dormitories shall be performed at least once every 36 months

(3) Fire safety and property maintenance inspections of all multiple dwellings not included in Subsection A (1) or (2), and all non-residential buildings, structures or uses and occupancies not included in Subsection A (1) or (2) shall be performed at least every 36 months
