Although the city charter states under a vacancy, the city council has the right to appoint, at no time does the charter state that you can appoint a councilman or women who has just come off serving 2 terms. I would also like to know why the council went into executive session to discuss issue concerning weather councilman Noman could run, when he was not a councilman at the time. I also want to know why this council does not have to follow the city charter as it is written and has this council been told by our city attorney or an outside attorney that this council has the authority to do this?

I would like this the council president to explain why it is not a conflict of internet for him to serve 2 positions, 1 as the City of Lackawanna Council President and 2 as the Lackawanna Asst. Superintendent of our Lackawanna Schools when he and the formal council president had a major issue with this when the 2nd ward councilwomen was working at the school as a clerk. I would like law department to please explain why it is not a conflict of interest. I asked this question on November 29, 2017 and did not receive an answer. Could you please answer now?

The Lackawanna City Charter is very clear you must be a legal resident to have a seat on the Lackawanna Council. This council took the mayor to task for violating the city residency requirement with a former

employee in 2013 and yet this council has done nothing to 3rd ward councilman William R. Leonard who does not live in the city of Lackawanna. I have information to show that Mr. Leonard has not been a resident of the city of Lackawanna since 2016. It also shows that while on the planning board he used his position as a way of intimidation. If these things are true, this gentleman must step down from the council immediately.

These questions I am asking the council need to be addressed. I hope you will address it.
