Willet Road Repaving

3. To: City Council

Mayor Szymanski received this correspondence from the Town of Hamburg-

Upon learning of the Mayor's request for a joint undertaking to repave Willet Road which rests on the Lackawanna/Hamburg border I was happy to consider the prospect of Hamburg's contribution to this project. Willet Road is a disgrace. The broken pavement and crater-sized potholes make the roadway unsafe at any speed. There are 15 homeowners on the Hamburg side of the road and one commercial property. The Lackawanna side is more densely populated, yet the citizens who use the street on a daily basis all agree that it is in awful shape.

Notwithstanding my interest in going forward, Hamburg Highway Superintendent Ted Casey nixed the project. He had developed his own priority list based on his own criteria for the application of funds for the repaving of Hamburg roads. Under the Highway Law of the State of New York the Highway Superintendent has exclusive authority to appropriate funds for reconstruction and/or repaying of Town streets.

However, I was told that Willet Road was in a Community Development Block Grant fund target area and would qualify for CDBG funding. I was thrilled to hear the news since Hamburg's contribution to the overall costs of the project could be realized through the appropriation of Federal dollars.

Much to my surprise, I learned on May 10th, that the original conclusion drawn by Chris Hull, Director of Hamburg Community Development as to Willet Road's placement in the target area may have been in error. Evidently some portions of Willet Road may qualify and others may be outside of the targeted area. By sending a copy of this letter to Chris Hull, I am instructing him to make whatever determinations he can make in the hope that Willet Road can be repave this summer without further delay.

Mr. Hull informs me that there may have to be a survey undertaken. I don't want to post-pone a decision and I don't want to add considerable expense to this project, nonetheless, I am asking him to do whatever is necessary to enable us to make a correct and final determination.

If Willet Road qualifies for CDBG funding then Hamburg will enter into a contract with the City of Lackawanna for the purpose of getting it done. I'm sorry to say that in the event that CDBG funds cannot be appropriated for this project, I have no authority to instruct the Highway Superintendent to make the necessary appropriation.

Thanks for your continued understanding. I hope we can move this project to completion.

Local Law:

A LOCAL LAW AUTHORIZING A PROPERTY TAX IN EXCESS OF THE LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW SECTION 3-C

Be it enacted by the City Council of the City of Lackawanna, New York as follows:

SECTION 1. LEGISLATIVE INTENT

It is the intent of this local law to allow the City of Lackawanna to adopt a budget for the fiscal year commencing August 1, 2018 that requires a real property tax levy in excess of the "tax levy limit" as defined by General municipal Law section 3-c.

SECTION 2. AUTHORITY

This local law is adopted pursuant to subdivision 5 of General municipal Law section 3-c, which expressly authorized a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

SECTION 3. TAX LEVY LIMIT OVERRIDE

The City Council of the City of Lackawanna, County of Erie, is hereby authorized to adopt a budget for the fiscal year commencing August 1, 2018 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law section 3-c.

SECTION 4. SEVERABILITY

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstances is invalid or unconstitutional, the court's order or judgment shall affect, impair or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

SECTION 5. EFFECTIVE DATE

This local law shall take effect immediately upon filing with the Secretary of State.

Dona Street (Lincoln School) Demolition Contract, Change Order 01

As you are aware, the Dona Street Demolition Project is moving forward, with additional funds and a significant change order based upon further testing. Please approve the change in the amount of -\$279,080 (a credit to the City against the original contract amount of \$1,277,560.00.

The application of this change order results in a new contract amount of \$998,480.

The change order restricts the handling of the area once thought to be wide spread with contaminated soil and restricts operations in dealing with the soil and subsurface. It creates a credit against line #1 for the quantity removal of soil. It includes abandonment of a footing in a limited area and accounts for a deduct in soil striping and storage.

The change order has been signed by the contractor and is actionable upon your approval.
