2017-18 Budget Amendment-Revitalization Initiative

As most of you are aware, in October 2017 the City of Lackawanna received a grant in the amount of \$2.5 million from the State's Buffalo Billion II Downtown Revitalization Initiative Smart Growth Fund for improvements to our central business district corridor. The initial grant allocation is for \$2,061,242 and in order for the City to access this money, your Honorable Body must approve using \$21,485.75 from the Fund Balance to subsidize the 1% grant commitment fee and an additional \$873.75 for reimbursement of out-of-pocket public hearing related expenses. The approved projects that will be funded through this allocation includes road infrastructure improvements at the intersections of both Ridge Road and South Park Avenue and Ridge Road and Electric Avenue, an upgraded pathway between the Botanical Gardens and Our Lady Victory Basilica and improvements made at Memorial Field to erect a pavilion over a part of the parking lot to establish a City Farmers Market on Wednesday or Thursday and Sunday beginning around Easter to the end of October, create food truck Friday's plus beautifying the passive spectator areas around the back of the softball fence with updated landscaping picnic tables and possibly grills for families to bring their own charcoal and food to make dinner while watching league games.

I am respectfully and humbly requesting that your Honorable Body approve the use of \$21,485.75 from the City's Fund Balance to meet our financial obligation to receive over \$2 million from the State. Thank you in advance for your assistance and cooperation on the matter.
