<u>17 (A).</u> AN ORDINANCE RESCINDING AND REPLACING CHAPTER 230, ZONING, OF THE CITY OF LACKAWANNA MUNICIPAL CODE

BE IT ENACTED by the City Council of the City of Lackawanna, New York that City Code Chapter 230-52 Unlicensed vehicles shall be rescinded and replaced as following:

- A. No unlicensed or unregistered vehicles shall be stored outdoors for more than 30 days.
- B. The outdoor storage of more than one unlicensed or unregistered vehicle, per parcel, is prohibited.
- C. Unlicensed or unregistered vehicles shall be stored at the rear of the parcel whenever possible.
- D. Unlicensed or unregistered vehicles shall be stored so that said vehicle is not visible from the public right-of-way, whenever possible.
- E. Unlicensed or unregister vehicles may be temporary stored at vehicle repair shops or automobile sales businesses which are in compliance with applicable zoning and licensing requirements, pending the repair or sale of such vehicle not to exceed 30 days.
- F. Junk vehicles, for the purpose of this section, shall be defined as any vehicle, including a trailer, which is without a current inspection sticker, insurance valid license plate or plates and/or is in either a rusted, wrecked, discarded, dismantled, partly dismantled, inoperable or abandoned condition.
- G. A junk vehicle may not he parked, stored outdoors or be visible from a public right-of-way. **THIS ORDINANCE SHALL TAKE EFFECT IMMEDIATELY**

Business Registration for 161 Steelawanna Avenue-Resident Comments

22. To: City Council

The purpose of this letter is to comment on the application submitted to operate a store at 161 Steelawanna Avenue.

I've resided across the street for the store for 20 years and in the neighborhood my entire life. Having been raised in the neighborhood, I am very familiar with the 3 previous owners. The store has always been a respectable business. However, a noticeable change occurred when the most recent owner (Edwin Borrero) chose to lease the store approximately 3 to 4 years ago to the current proprietor.

The following are a few "issues" that have arisen since Edwin turned the store over to the new proprietors:

* The store rarely closes prior to 2 am.

* There has been a drastic difference in the customer base and not for the good.

* I have personally witnessed drug transactions in front of the store.

* Customers leave tremendous amounts of liter in the street, sidewalks and lawns including food containers, broken liquor bottles, and drug paraphernalia.

* Cars are often left running with loud music playing and vibrating my house. The music is so loud I often can't hear the TV and have to relegate myself to the rear of my house to watch TV.

* Cars often block my driveway. On one occasion I was yelled at by an Officer Gorska for calling the police desk 3 times to complain that I could not get into my own driveway.

- * Public urination in the driveway of the store.
- * The sound of screeching tires is very common due to cars speeding around the corner.
- * I have had property damage as a result of a speeding car knocking down my fence.
- * A vicious assault took place approximately 2 years ago outside of the store.

All of this has taken place since the business changed to the Nagi family. There have been various individuals (I presume all are related) with the last name Nagi that are associated either with the liquor license, or property ownership.

While I am a strong believer in small business ownership, the business should not be a nuisance to the neighborhood.

I'm not certain what is going on inside of the store, but the atmosphere the store has created makes their customers comfortable in doing all things I indicated above. There is no reason for a small neighborhood store to be open at 12 midnight. I doubt the store sells milk, produce and bread, but if they did, no one would be purchasing those items at 12 midnight.

Again, I do not want to hinder anyone's livelihood, but no one has the right to create a miserable environment for the sake of owning a corner store. This is how the demise of safe and decent neighborhoods start. If nothing is done to stop these problems it will only escalate.

The previous owners made an honest living at the store while running a respectable clean decent business.

I respectfully ask that everything outlined above be taken into serious consideration when deciding to approve the application with the current hours of operation indicated. Also, ask yourselves how you would feel as a homeowner and taxpayer if this business were located next door or across the street from your house.
