Questions for the Council

17. To: City Council

- 1. On August 20, 2018 at the council meeting, Council President Annette Iafallo request the City Council change the criteria for Honorary Street-Renaming. The council tabled this item for the next council meeting which was on September 4, 2018 but it was not even discussed even though you know this was on the citizen's minds. Some citizens came to the meeting specifically for this but could not address the issue. The related comments and questions I have for you are the following:
- A. On May 1, 2017 former Council President Lewis and former Council member Joe Jerge had a proposal regarding the recommendation procedures for renaming streets.
- B. On 06/06/2017 City Clerk asked Council to approve a resolution establishing a non-binding street naming committee as per the guidelines authorized by the recommendation/procedures for renaming streets, which was approved at the May 1, 2017 regular meeting. This also required the approval of committee candidates who were:
- 1st Ward- Mona Abdul 2nd Ward- Mark Friend 3rd Ward- Nancy Whelan 4th Ward- Thomas A. Fino
- C. On April 18 this council approve by 5-0 to approve procedure for renaming streets after certain requirements were met. This was approved by the council.

My question: When did the approval of renaming a street after a country get approved? Under the requirements for a street to get a name change it does not say you could do that. Also how come it was never brought up at a council meeting? I have looked at all council meetings from 2017 till 2018 and cannot find when and where this was approved.

My second question is concerning "Hearings from Citizens". The Council President Mrs. Iafallo has said the council has stated it has decided to only answer questions that are on the agenda due to the fact they were getting questions that they could not answer on the spot, and if they put it on the agenda that would give them more time to give an answer. The problem with that statement is that-

- 1. You must put your question to the council 1 week before council meeting and it must be in by Wednesday 12:00 noon
- 2. Although at council meetings where we have city department heads present, we have seen this council ask these dept. heads question about things they knew could not be answered on the spot...where this council has the ability to go into dept. head offices and get information before a council meeting.
- 3. Although we agree certain items should be put on the agenda by citizens, "Hearings from Citizens" means just that. Hearing from them, there may be issues that one of these 18,000 citizens of Lackawanna need to address, and it may not have happened in that prior week that you need to put an item on agenda. When a citizen of Lackawanna comes to the city council, which is a public meeting to address certain issue that affect their community, we should at least expect our elected officials to hear us out. We the citizens should be able to address this council for a few minutes per meeting, even if it is not on the agenda. We used to have both in Article 111 Rules of Procedures

Rule 10 Hearing from citizens

Please quit saying you changed this rule for citizens; you did not. Even though some citizens do not act right and try to grandstand, the majority of the citizens of Lackawanna who come to these meetings on a regular basis because they care for their city, and only want to help. But when elected officials we elected try to change or make rules that stop regular citizens from being able to question their public servants because it is not on an agenda, or the question may seem distasteful, this is wrong and needs to be challenged.
