# 2017-2018 Budget Amendment-Environmental Restoration Program

# 13. To: City Council

In 2007 the City of Lackawanna entered into a State Assistance Contract with New York State Department of Environmental Conservation under the Environmental Restoration Program in the amount of \$122,170. 60 for the brownfield clean-up of 113 through 135 Ridge Road (now home to Family Dollar). The State paid \$109,953.54 (90%) and the City paid \$12,217.06 (10%) of the clean-up costs with a provision that the City would reimburse the State for a portion of the clean-up based on the purchase prices plus taxes owed to the municipality upon acquisition of the site. These parcels have now been sold to family Dollar, care of the Durban Group and our reimbursement obligation to the State is \$71,131.09. Therefore, I am requesting to create Line Item A8674.401 State Restoration Reimbursement and amend the budget to fund this Line by \$71,131.09.
