## ORDINANCE

## AN ORDINANCE AMENDING 5-22, ARTICLE III, RULES OF PROCEDURE AND REENACTING IT AS FOLLOWS:

## SECTION 5-22. Order of Business.

A. Promptly at the hour set by law on the day of each regular meeting, the members of the Council and the City Clerk shall take their regular stations in the Council Chambers; and the business of the Council shall be taken up for consideration and disposition in the following order:

- (1) Roll call.
- (2) Hearing from citizens.
- (3) Approval of minutes of previous meeting.
- (4) Departmental reports

(5) Communications from Mayor and introduction and adoption of resolutions, ordinances and local laws related to said communication.

(6) Communications from the Council and introduction and adoptions of resolutions and ordinances and local laws related to said communication.

(7) Communication from department/division heads and adoption of resolutions, ordinances and local laws related to said communication.

- (8) Communications from citizens.
- (9) Tabled Items.
- (10) Old Business.
- (11) Adjournment.

**B.** In Subsection **A(2)** above, only communications on the agenda items will be considered. The presiding officer is empowered to waive this restriction if he or she so deems.
