Nason Pkwy and Ridge Road Quieting Measures and Improvements

The City is looking at street quieting measures and improvements along Nason Parkway and Ridge Road to better connect our City with the regional resources of South Park, the Erie County Botanical Gardens, and the Basilica.

As part of our efforts we have planned improvements to connect the park through a pocket park between Ridge Road, and Nason Parkway. The pocket parkway is one of the amenities to be funded through the DRI Grant, pending extension of the implementation time for the same.

In addition we see benefit in restricting Nason Parkway to a one way street allowing southerly traffic to exit onto South Park, and the creation of bike lanes along the street.

The proposed changes to Nason Parkway are the topic of a public hearing scheduled to be held in the Council Chambers on March 5th, 2020 at 6:00pm.

RE: Supporting Assemblyman Burke's dangerous hearings legislation known as the "Justice for Rachel" Act (A.06688A)

WHEREAS, bail reform measures were included in the 2019 New York State omnibus budget package; and

WHEREAS, these reforms are causing significant concern in our community and among law enforcement officials; and

WHEREAS, New York State Assemblyman Patrick Burke has introduced legislation that would establish a system of dangerousness hearings that would create a process to keep potentially dangerous individuals in pre-trial custody; and

WHEREAS, the legislation adds a new section 510.55 of the criminal procedure law; and WHEREAS, section 510.55 of the criminal procedure law establishes the conditions under which the people may seek pretrial detention due to the dangerousness of the principal; and

WHEREAS, upon the appearance of the principal charged with an offense listed in subdivision 1 of the legislation, and upon the motion of the people, the judge shall hold a dangerousness hearing. After the hearing and pending trial, the judge shall issue an order that either the individual be released on his or her own recognizance, released on certain conditions, or detained; and

WHEREAS, if after the dangerousness hearing, the judge finds by clear and convincing evidence that no conditions of release will reasonably assure the safety of any other person or the community, the judge shall order the pretrial detention of the principal; and

WHEREAS, this legislation is named in memory of Rachael Wierzbicki, who was killed in a domestic dispute and her alleged murderer was promptly released on bail, not considering the danger he posed to the community.

NOW, THEREFORE, BE IT

RESOLVED, that the City of Lackawanna goes on record in support of the "Justice for Rachael" Act in the New York State Assembly; and be it further

RESOLVED, that a certified copy of this resolution is sent to New York State Governor Andrew Cuomo, the Speaker of the New York State Assembly Carl Heastie, Senate Majority Leader Andrea Stewart-Cousins and any other party deemed necessary and proper.

Renewable Energy Resolution

RESOLUTION NO. 5, 2020

WHEREAS, On February 21, 2020, Governor Cuomo submitted a 30-day budget amendment entitled 'Accelerated Renewable Energy Growth and Community Benefit Act" for the purpose of meeting the Governor's goals for renewable energy, and

WHEREAS, This amendment would establish a new system for permitting and siting renewable projects, setting aside the current "Article 10 Siting board" process, and

WHEREAS, Permitting will now be under the jurisdiction of a new entity – Office of Renewable Energy Siting (ORES), and

WHEREAS, the powers assigned to ORES will totally usurp and diminish local home rule, local zoning codes, local planning and Local Waterfront Revitalization Plans when permitting and siting renewable energy projects, and

WHEREAS, ORES will now have the power to Make available to developers "build-ready" sites Develop "uniform permitting standards" "coordinate, approve, evaluate, issue, amend, transfer and enforce siting permits" Limit the ability of local governments to raise objections to proposed projects Direct local appeals to ORES decisions to litigation through the Article 78 process Prohibit local governments from requiring any additional approvals or permits

WHEREAS, By filling this action as a 30-day budget amendment, is ignoring and bypassing the legislative process of formulating policy through public input, public hearings and public debate in favor of a rushed and secretive process, and

WHEREAS, This amendment represents a blatant attempt to usurp local government's historical and constitutionally power of home rule in the areas of planning, zoning and land use.

NOW THEREFORE BE IT RESOLVED, that the City of Lackawanna does hereby go on record strongly opposing this Governor's attempt to dilute and usurp the roles and powers of local governments in New York State, and

FURTHER BE IT RESOLVED, that the City of Lackawanna urges New York State Legislators to oppose this amendment and have it removed from the final budget document and,

BE IT FURTHER RESOLVED, that a certified copy of this resolution be forwarded to Honorable Governor Andrew M. Cuomo, Honorable Lieutenant Governor Kathy Hochul, Honorable Speaker of the Assembly Carl E. Heastie, Honorable Senate Majority Leader Andrea Stewart-Cousins, Honorable Democratic Minority leader John J. Flanagan, Honorable Majority Leader of the Assembly Crystal People-Stokes, Honorable Minority Leader of the Assembly William A. Barclay, and the Western New York Delegation and Erie County Executive Mark Poloncarz and the Erie County Legislature.
