#### **Communications from the Mayor:**

- 6. Mayor Iafallo Submits the annual Budget Message to the City Council and a communication requesting the City Council to repeal Article 19, particularly Section 1903 of the Real Property Tax Law, which re-establishes a unified tax rate to ensure Lackawanna's economic future and to attract new businesses to the City. The Mayor is requesting the City Council approve the attached Budget Ordinance and Local Law.
  - \*Agenda items #8(A) and #6(B) must be addressed prior to voting on the budget ordinance #6(A).
  - (A) \*An ordinance adopting the current expense budget of the City of Lackawanna for the fiscal year 2020-2021. The sum of \$12,755,884.00, being the entire amount determined to be necessary to be raised by taxation to defray the expense of the City for 2020-2021 fiscal year, with a Unified Tax Rate of \$17.23 of assessed valuation.
  - (B) A local law repealing and amending Chapter 201. Article IV of the Lackawanna City Charter and known as the Homestead and Non-Homestead Base Proportions. That Chapter 201, Article IV, section 201-16 through 201-19 of the Lackawanna City Charter, entitled Homestead and Non-Homestead Base Proportions is hereby replaced in its entirety.

#### **Communications from Division/Department Heads:**

- 8. <u>City Comptroller</u> Requests City Council approve the attached Local Law to allow the City of Lackawanna to exceed the Property Tax Cap for the fiscal year 2020-2021 as prescribed in General Municipal Law Section 3-c.
  - (A) An Local Law authorizing a Property Tax in excess of the limit established in General Municipal Law Section 3-c. The City Council of the City of Lackawanna, County of Erie, is hereby authorized to adopt a budget for the fiscal year commencing August 1, 2020 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law Section 3-c. This local law shall take effect immediately upon filing with the Secretary of State.
- 9. <u>Fire Chief</u> Requests City Council approve the selling of the following old Fire Department vehicle and equipment. The vehicle to be sold is a 2002 Chevy Suburban as it can no longer be used for Fire Department services because of safety issues. The equipment to be sold includes ladders more than 25 years old that no longer serve the Fire Department due to their age and condition. I am asking for permission to destroy any unsold items.
  - In addition, I request the City Council to approve the funds received from the sale of the listed items be placed in Fire Department budget code A.3410.0443 to cover the costs of maintenance on our service apparatus.
- 10. <u>DPW Commissioner</u> Requests the City Council award the bid for the Galanti Park Restoration Project to Occhino Corporation in the amount of 203,193.50. Bids received are attached.

11. <u>City Attorney</u> – There is an additional fire hydrant installed at 2800 Hamburg Turnpike. I request the City Council please approve the attached resolution authorizing the yearly maintenance fee in accordance with the City's existing Water Authority contract #WSA-014. The cost is approximately \$229.08 per year for the annual maintenance fee.

In addition, I request the City Council rescind the prior resolution for the installation of a hydrant at 3904 South Park Avenue.

- (A) A resolution whereas the City Council authorizes the addition of the additional fire hydrant at 2800 Hamburg Turnpike to its existing Water Authority contract #WSA-014, and agrees to pay the annual maintenance fee to the Erie County Water Authority in accordance with the current contract #WSA-014.
- 12. <u>Director of Development</u> Requests the City Council approve the attached ordinance revising the City Permit Fee Schedule. It has been determined that the City fee schedule does not cover the cost of reviewing plans, and inspecting projects, and we have further determined that the City's fee schedule is substantially lower than that of surrounding municipalities. (Complete copy of the proposed fee schedule and comparison on file in the City Clerk's Office).
  - (A) An ordinance amending Chapter 75-16, Building Code Administration, of the City of Lackawanna Municipal Code, specifically the Permit Fee Schedule, together with the Penalties for work performed without a permit.
- 13. <u>Director of Development</u> Requests the City Council, as per the power pursuant to New York General City Law Section 20, review and approve the attached resolution regarding City Wide Zoning Code Amendments to regulate the use of land within and the area restrictions of said land usage.   - (A) A resolution that amends the following sections of City Code:
