NOW, THEREFORE BE IT RESOLVED, that the Lackawanna City Council submits the following projects to be considered for funding by the Erie County Community Development Block Grant Program during the 2021-22 grant cycle:

1st Priority - Center Street Complete Road Reconstruction requesting \$150,000 in CDBG funds;

2nd Priority - Construction of Center Street Concrete Curbs and ADA ramps, requesting \$150,000 in CDBG funds;

Combined these two projects are estimated to cost \$1,948,207.43.

3rd Priority - Construction of Bicycle Trail on Ridge Road from Route 5 to Abbott Road requesting \$200,000 in CDBG funds.
