**Communications from Department/Division Heads:**

1. **Director of Development** – Requests City Council approve the attached ordinance adopting changes to Section 230-17 of the City of Lackawanna Zoning Code pertaining to the Bethlehem Redevelopment Area (BRA).  
**(Proposed changes to Zoning Code 230-17 are located on the city website and FaceBook page)**
  - (A) An ordinance amending Chapter 230-17 of the Zoning Code of the City of Lackawanna, NY whereby the 2021 amendments to Chapter 230-17 of the City of Lackawanna Charter and Code identified in Schedule A attached hereto are determined to pose no adverse impacts on the environment, are determined to be consistent with the City of Lackawanna's duly adopted LWRP, Brownfield Opportunity plan, and Comprehensive Plan, and the ECILDC's GEIS for the site.  
  
Furthermore, the City Council adopts the Negative Declaration for the action of adopting the 2021 Amendments to chapter 230-17 of the City of Lackawanna Charter and Code and that the 2021 Amendments to Chapter 230-17 of the City of Lackawanna Charter and Code identified in the fore stated Schedule A are hereby adopted.
2. **DPW Commissioner** – Requests the City Council approve the attached resolution authorizing Mayor Iafallo to apply for grant money for the Warsaw Bridge.
  - (A) A resolution authorizing the Mayor to enter into such agreements, contracts, and/or memorandum of understanding in order to effectuate the contemplated repair or replacement of the Warsaw Street Bridge as well as enter into such agreements , contracts, and/or memorandum of understanding with the City's grant writer, Connie Miner.
3. **Director of Public Safety** – Requests the City Council, as per the attached resolution, adopt the attached (previously provided) Public Employer Health Emergency Plan in its entirety.
  - (A) A resolution whereas the City of Lackawanna adopts the attached Public Employer Health Emergency Plan in its entirety; and that the attached plan be implemented immediately, posted on the City's website, and otherwise posted throughout City Hall and made available to all employees and Department Heads.
4. **Director of Public Safety** – Requests the City Council, as per the attached resolution, adopt the attached (previously provided) Police Reform and Reinvention Collaborative Plan.  
**(Entire plan may be reviewed on the City website and FaceBook page)**
  - (A) A resolution whereas the City of Lackawanna hereby adopts the attached Police Reform and Collaborative Plan effective immediately; and that such plan is hereby offered for additional public comment to all citizens via a public hearing on this matter to be held on April \_\_\_\_\_, 2021; and the City Council hereby reserves the right to amend or revise the terms of such plan as may become necessary upon further public comment.
