The elevated railroad tracks surround the property, and the surrounding properties severely limit access to the property.

The site has been on the City Web page and available property posted by the City Assessor's Office, and was on listing of available properties published previously.

We have had no other offers.

We do submit the price is reasonable taking into account the past heavy industrial use of the site, sales of other properties and the limited access to the site.

The proposed use does include material recycling, and will also include some rock crushing.

Establishment of the use will be subject to Site Plan Approval by the Planning Board.

The request is to consider adoption of the Negative Declaration and authorize the Mayor to execute the attached proposed Sales Agreement.

Resolution Authorizing Sale of 2 North Steelawanna

WHEREAS, pursuant to Chapter 12 of the City of Lackawanna's Charter and Code the City Assessor has maintained, and published on the City of Lackawanna's web site, a list of property available for sale; and

WHEREAS 2 North Steelawanna is an approximately 8.37 acre parcel of former industrial property that has lain fallow for over 10 years which has been maintained as available for purchase for a number of years; and

WHEREAS said parcel has limited accessibility due to it being surrounded by elevated railroad beds; and

WHEREAS said parcel was formerly used for the storage and transport of materials related to the former Hanna Furnace steel manufacturing facility, which was abandoned decades ago.

WHEREAS the Office of the Assessor has negotiated a proposed sale of the property to 2 Steelawanna Ave LLC, an entity related to demolition contractor Metro Contracting & Environmental, Inc., for a price of Ninety Three Thousand Five Hundred (\$93,500.00) for use as a "Contractor's Yard" to support it operations; and

WHEREAS the Code Enforcement Officer has determined that said proposed use is consistent with Industrial zoning of the property.

WHEREAS the Applicant has prepared an Environmental Assessment Form Part 1, covering the sale, which has now been submitted to us together with Environmental Assessment Form Part 2 and 3 prepared by the Office of Development, together with proposed Negative Declaration; and

WHEREAS the action is an unclassified action for which an uncoordinated review is permissible and is being undertaken; and

WHEREAS prior to the establishment of any new use of the Site said actions will have to be reviewed by the Planning and Development Board which will then have to conduct their own SEQRA review; and

It is now

DETERMINED that:

- 1. The proposed sale of the land for productive industrial reuse is consistent with the duly adopted master plans of the City including the City's Comprehensive Plan, and the City's Brownfield Opportunity Plan; and
- 2. The use of an uncoordinated for review of the sale of the land and the reuse of the site after a final site plan is prepared and reviewed is no less protective of the environment than a coordinated review; and

RESOLVED that this governing body hereby approves adoption of the proposed Negative Declaration, and execution of the Part 3 SEQRA Determination of Significance prepared by the Office of Development, and

RESOLVED that the Mayor of the City of Lackawanna is authorized to execute all documents necessary to sell 2 N Steelawanna Avenue for \$93,000 to 2 Steelawanna Ave LLC.
