- 8. <u>DPW Commissioner</u> Requests the City Council rescind the no left-turn from the westbound lane on Ridge Road south onto Lehigh Avenue.
  - (A) An ordinance amending Chapter 215, Traffic and Vehicles, of the City of Lackawanna Municipal Code, specifically Chapter 215.9 Turning movements, shall be amended by rescinding the following:

215.9(A)(2) Vehicles proceeding west on Ridge Road are prohibited from turning left onto Lehigh Avenue.
