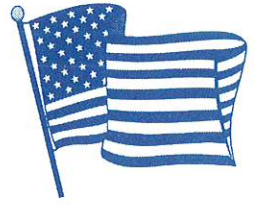

ORDINANCE

AN ORDINANCE AMENDING THE 2021-2022 BUDGET ORDINANCE ADOPTED
MAY 18, 2021.

BE IT ENACTED by the City Council of the City of Lackawanna, New York as follows:

SECTION 1. That the 2021-2022 Budget Ordinance adopted May 18, 2021 is hereby amended to increase the number of Assistant City Attorneys from one to two.

SECTION 2. That the 2021-2022 Budget Ordinance is hereby amended to increase budget code A.1420.0101 Department of Law - Assistant City Attorney by \$12,000.00.

SECTION 3. That the 2021-2022 Budget Ordinance is hereby amended to appropriate \$12,000.00 from budget code A.1900.1930 Special Items – Judgments and Claims.



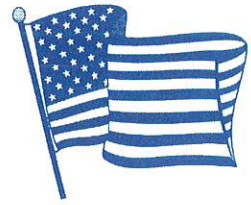
