## <u>Requests Approval of Resolution Authorizing the Mayor to Execute any and all Settlement</u> <u>Agreements as Recommended by the Cherundolo Law Firm and the City Attorney to Effectuate an</u> Opioid Settlement Agreement.

Re: Opioid Settlement Agreements

Hon. Council Members:

As you may know the City of Lackawanna is a plaintiff in claims brought against numerous opioid manufacturers, distributors, pharmacies and others who were involved in manufacturing or distributing or selling opioids. The City of Lackawanna retained Cherundolo Law Firm out of Syracuse New York who has filed state court actions on behalf of the city as well as other political subdivisions. A substantial

number of these claims have been consolidated and filed or transferred to federal court because of their class action status. In addition the State of New York has passed legislation recently limiting a municipality's ability to pursue independent claims and the Atty. Gen. of the State of New York is also overseeing a number of these claims.

Attached is a subdivision settlement participation form, a New York subdivision election and release form and a New York Opioid settlements sharing agreement. In order for the City of Lackawanna to participate in settlements against four of the defendants who are distributors our Syracuse counsel has recommend that the city execute the attached and return to them by Tuesday, November16. Under a settlement agreement reached with 4 of the distributors the city will receive payments of about \$68,186. These payments will be paid over an 18 year period. Also the money paid must be used in accordance with the terms of the settlement agreement for opioid or substance use disorder related projects or programs. The agreement also provides that the city will on an annual basis account for any monies received and how those monies were spent. Due to the time sensitivity of this matter I am asking that the Council hold a special meeting on Monday, November 15 to authorize the Mayor to sign the attached agreements. In addition I am asking for Council Approval for the Mayor to sign and enter into any other related settlement agreements as future claims are resolved. Very truly yours,

**Resolved** that the Mayor is hereby authorized to execute any and all settlement agreements as recommended by the Cherundolo Law Firm and the City Attorney to effectuate settlements on the City's behalf; and be it further

**Resolved** that the Mayor is authorized to enter into a New York opioid settlement sharing agreement, a New York subdivision election and release form and a subdivision settlement participation form to effectuate a settlement with four (4) distributors; and be it further

**Resolved** that the Mayor is authorized to sign any and all other agreements necessary to effectuate settlement in the amount of \$68,186.00 with Johnson & Johnson, McKesson Corporation, Cardinal Health, Inc., and Amerisource Bergen Drug Corporation.
