Dear Council-

I am requesting that your Honorable Body pass the attached resolution showing the City of Lackawanna supports New York Bill S7602, the Donor Conceived Person Protection Bill. This Bill was brought to my attention through the Association of Erie County Governments.

A couple was unable to conceive children and reached out to a fertility specialist. The specialist recommended Fairfax Cryobank, where a candidate was selected, and the couple had a son. Their son's life was filled with unimaginable suffering, illness, hospitalization, rehab and incarcerations. He was diagnosed with schizophrenia at age 19. Tragically the son died at the age of 27. Soon after the couple found out that the donor had the same problems and died of an overdose at age 46.

Here is a brief summary of the Bill-

A more detailed medical history for any sperm donors, such as whether the donor has any psychiatric disorders and/or had been hospitalized for anything other than a surgery.

**WHEREAS,** The City of Lackawanna acknowledges the importance of parents and donor-conceived persons knowing the medical, educational and criminal felony conviction history of individuals who have donated reproductive tissue to a reproductive tissue bank for the purposes of an artificial insemination or assisted reproductive technology procedure and disseminating history information to a recipient and donor-conceived person upon request, if any; and

**WHEREAS**, the City of Lackawanna further acknowledges knowing the medical, educational and criminal felony conviction history of a donor will provide recipients with the necessary information to make informed decisions regarding the process of artificial insemination or assisted reproductive technology procedure and for donor conceived persons to obtain essential medical information, which may reveal any genetic or mental health disorders;

WHEREAS, the City of Lackawanna finds that reproductive tissue banks, including semen banks, oocyte donation programs and embryo banks have a duty to collect and verify medical, education and criminal felony conviction histories and information provided by donors on donors self-reported medical, educational and criminal felony conviction histories and during the donor screening process and to keep detailed records of such for use by recipients and donor-conceived persons, if any, prior to a procedure and in the future,

**THEREFORE, BE IT RESOLVED,** the City of Lackawanna fully supports the passage of NYS Senate Bill S7602, sponsored by Senator Patrick M. Gallivan and supports further efforts to insure both parents and donor conceived persons have access to verified medical, educational and criminal felony conviction histories for all donors.

Further, I encourage you to discuss my letter at your next board meeting and consider writing a letter to the Erie County Agricultural Society officials letting them know your thoughts. They have long used the label "America's Fair" but are acting in a very un-American way by not honoring those who sacrifice every day for their neighbors.

#### No Fair for Me

As both a Purple Heart Veteran and a Volunteer Firefighter, I have always enjoyed attending the Erie County Fair on those days when they honored both those groups. I looked forward to seeing friends from both near and far as we gathered together in spirit of brotherhood.

For many years the fair has allowed these groups to have dugouts on the infield where they could socialize with other units and honored them with a special parade.

After a history of 180 years, Jessica Underberg, CEO of the E.C. Fair, has determined that these gatherings are a liability and safety issue and will not allow this tradition to continue. I consider this to be a slap in the face for these two groups and all they have sacrificed and continue to do for our communities and our country every day.

It reminds me of all the nurses who risked their lives and were celebrated as heroes for getting us through the pandemic and then were fired for not getting the vaccine as mandated by Erie County. I feel that is extremely disrespectful to our veterans and fireman to not allow them to have a parade to thank them and celebrate their sacrifice to our nation.

Liability and safety concerns? Will they cancel the two days of the demolition derby next? In all my years of watching parades, I have never seen two fire trucks crashing into each other! Whoever is making these decisions should be replaced.

I would encourage all veterans and firefighters to boycott the Erie County Fair this year. Instead wear your uniforms and go to the Cattaraugus, Chautauqua, Niagara, or Wyoming county fairs. You will have a fun day, spend less and be greatly respected for all you do. I'll see you there!
