Separate sealed Bids for the City of Lackawanna, Center Street Reconstruction Project will be received by the City Clerk, City Hall – Room 215, 714 Ridge Road, Lackawanna, NY 14218 until **10:45 a.m. (local time) on Thursday, October 20<sup>th</sup>, 2022** and then opened and read aloud at Council Chambers, 2<sup>nd</sup> floor, City Hall, at 11:00 a.m.

Bids sent by email, fax or bids not enclosed in a separate sealed envelope within an unmarked generic delivery service envelope will not be accepted. The City is not responsible for any late postal deliveries of the bid package

This project includes the installation of approximately 3,350 linear feet of new 8" DR-18 PVC water main and appurtenances, rehabilitation of the existing storm sewer through new crossing pipes, spot repairs and new drainage structures, and full depth roadway reconstruction of Center Street from Ridge Road to Kirby Avenue, with new concrete curb, sidewalk, and handicap accessible ramps. Bid Alternate #1 will include the installation new sanitary sewer laterals. The project will be separated into three shares for payment items and quantity tracking, but bid as one complete project via unit prices.

It is expected that the construction of the water main and sanitary sewer laterals will occur first and begin in the 2022 construction season with storm sewer and roadway reconstruction taking place in the spring of 2023.

A pre-bid conference will be held on site at Center Street and the corner of Ridge Road, Lackawanna, NY 14218 at 11:00 a.m. on Tuesday, October 11<sup>th</sup>, 2022.

Copies of the Contract Documents may be obtained **ONLY** at the office of the Engineer, on **Monday, September 26<sup>th</sup>**, **2022**, upon payment of \$50.00 for each set. Checks for Contract Documents should be made payable to the City of Lackawanna. Requests for mailing of Contract Documents shall only be made to the Engineer and sent to CPL; 26 Mississippi Street, Buffalo, NY 14203. Enclosed with the request for mailing shall be two checks: one check made payable to the City of Lackawanna for \$50.00 for the Contract Documents; and a check made payable to CPL for \$25.00 for handling and mailing fees. Those wanting to pick up the documents in person should come to CPL; 26 Mississippi Street, Buffalo, NY 14203.

Each bid must be accompanied by a certified check or bid bond from a domestic carrier licensed to do business in the State of New York in the amount of not less than five (5%) of the amount of the bid sub- mitted.

Bidders on this work will be required to comply with the President's Executive Order Nos. 11,246 and 11,375 which prohibit discrimination in employment regarding race, creed, color, sex, or national origin.

The successful bidder must be an equal opportunity employer, must meet all appropriate State and Federal standards, and 00020-1

comply with all relevant governmental regulations.

Minority Owned Business Enterprises (MBE) and Women Owned Business Enterprises (WBEs) firms are encouraged to respond.

This contract will be funded wholly or partially with federal funds, and as such, is subject to all federal rules and regulations pertinent thereto, including, but not limited to, federal policy of encouraging the participation of minority and women business enterprises as sources of suppliers, equipment, construction and services.

Statement of Non-Collusion: Bidders on the contract are required to execute a non-collusive bidding certificate pursuant to Section 103d of the General Municipal Law of the State of New York.

Security for Faithful Performance: The successful bidder will be required to furnish Performance and Labor and Material Payment Bonds written by firms licensed to do business in New York State, each in the amount of one hundred percent (100%) of the contract amounts in accordance with the provisions of the Contract Documents.

Bidders shall comply with the Iran Divestment Act of 2012.

Sales and Use of Tax Exemptions: The City of Lackawanna is exempt from the payment of sales and compensation use taxes of the State of New York and of cities and counties on all materials, equipment, and supplies sold to the City of Lackawanna pursuant to this contract. Also exempt from such taxes are purchases by the Contractor and his/her Subcontractors of materials, equipment, and supplies to be sold to the City of Lackawanna pursuant to this contract, including tangible personal property to be incorporated in any structure, building, or other real property forming part of the project. These taxes are not to be included in the Bid.

All bids shall be binding for a period of forty-five (45) days after the bid opening date. The City of Lackawanna reserves the right to reject any and all bids and to waive any informality therein.
