- 2. Mayor Iafallo requests the City Council approve an amended communication to item #1 above, approving the establishment and budgeting of funds allocated to record overtime worked during the November 2022 Snow Storm, between 11/17/22 at 8:00 p.m. to 11/23/22 at 11:59 p.m. This action is required in order to track expenses for reimbursement purposes from FEMA.
