AN ORDINANCE AMENDING CHAPTER 116 OF THE CODE OF THE CITY OF LACKAWANNA ENTITLED EVICTION FOR ILLEGAL DRUG ACTIVITY

116.4 BE IT ENACTED by the City Council of the City of Lackawanna, New York that the following sections of Chapter 116 shall be rescinded and replaced as follows:

116.4 SERVICE OF NOTICE, COMMENCEMENT OF EVICTION PROCEEDINGS

B. If the owner or landlord, or his agent, does not make such application within five days thereafter, or having made it, does not in good faith diligently prosecute it, the person, corporation or enforcement agency giving notice may bring a proceeding under this chapter for such removal as though the petitioner were the owner or the landlord of the premises, and shall have precedence over any similar proceeding thereafter brought by such owner or landowner or to the one theretofore brought by him and not prosecuted diligently and in good faith. Proof of illegal drug activity at the desired premises or by the occupants thereof, or if those resorting thereto, shall constitute evidence of the unlawful use of the demised premises required to be stated in the petition for removal. Notwithstanding the provision of Section 116.5 and 116.6 of this Chapter, multiple instances of illegal drug activity are not required to commence an eviction proceeding under this Chapter. Both the person(s) in possession of the property and the owner or landlord shall be made respondents in the proceeding under this Chapter.

116.6 OTHER EVIDENCE OF PROHIBITED CONDUCT AS PRESUMPTION OF THE EXISTENCE OF ILLEGAL DRUG ACTIVITY

Two (2) or more incidents of the following activities at any building, structure or real property within one (1) year period prior to the commencement of a civil action by notice of such action as provided within this Chapter shall be prima facie evidence of the existence of illegal drug activity.

- (1) Service of an accusatory instrument charging any of the offenses defined in Article 220 and 221 of the New York State law occurring upon the property. For the purposes of this section, an accusatory instrument shall include, but not be limited to, any criminal information, misdemeanor and/or felony complaint filed in a court of competent jurisdiction.
- (2) Service of a search warrant on the building, structure or real property where controlled substances, marihuana [marijuana], drug paraphernalia and/or weapons are seized.
- (3) Recovery of illegal controlled substances, drug paraphernalia or illegal firearms or weapons on the building, structure or real property.
- (4) Investigative purchases of illegal controlled substances on the building, structure or real property by law enforcement agencies of their agents.

116.7 CIVIL PENALTIES

A court granting a petition pursuant to this section may, in addition to any other order provided by law, make an order imposing and requiring the payment by the respondent of a civil penalty not exceeding five-thousand dollars (\$5,000.00) to the City of Lackawanna, in which subject premises is located, and the payment of reasonable attorneys' fees and the cost of the proceeding to the petitioner. In any such case, multiple respondents shall be jointly and severally liable for any payment so ordered, and the amounts of such payments constitute a lien upon the subject property.

Proposed Operating Budget for 2014-2015

6. To: City Council

Pursuant to Chapter 12, Section 12.3 and 12.4 of the City Charter, I submit herewith my proposed budget for the City of Lackawanna for fiscal year August 1, 2014 through July 31, 2015.

The proposed General Fund Operating Budget figure of \$23,645,413 reflects an increase from last year's budget. The total tax levy of \$9,727,429 reflects an increase of \$477,348 from last year's budget.

I am presenting to you my budget for the 2014-2015 budget year. In this budget, I am presenting a commonly used form of revenue that will be shared by all entities within our city. It is an

"Enterprise Fund" in which the cost of garbage/sanitation of the Department of Public Works will be placed in this fund. A user fee will be charged and the resulting revenues will be used to cover the expenses. These revenues are solely from the user fee and separate from the tax levy as well as not subject to the tax cap. This will take a local law to be adopted prior to the Enterprise Fund being established and the budget voted on.

To inform the members of the City Council, almost all revenues are down. These valuable funds that are down are PILOT's, Sales Tax, Coin, Cable Franchise, Treasurer's Fees, Clerk's Fees, Development, Police Fees, Vital Stats, Civil Service, Franchise Fees, Interest on Real Property, Bingo, Other Licenses, Sale of Real Property, Refunds, Other Revenues, Roadway Safety Grant and Lunch Program. The largest reduction comes from Sales Tax, down \$300,000.00.

Our staffing level is below what I would consider a safe level, particularly in the Police Department. Throughout this process, I have tirelessly tried to avoid any form of layoffs. Many have families and wish to grow in this city, while others are looking to start families. Through this dedicate process; I have been able to avert any layoffs from this budget. As a city, we still must be able to provide quality services for our residents, the most visible services are public safety and recreation.

Also, to simplify some of the major accounts in the General Operating Budget, health care is almost \$3,721,705, salaries are \$10,979,795, retirements are over \$2,594,688, and debt service is over \$1,300,000, street lighting is \$735,000 and fire hydrant rental is \$115,000. This is over \$18,600,000 and this doesn't cover contractual items and other day to day operations.

As usual, I am looking to use fund balance to help offset the deficit. This will leave us with \$2,000,000 left for a healthy fund balance reserve which we must have to help offset any unforeseen situations, including weather disasters.

One doesn't have to travel far to see the lack of growth in our community, specifically, business. As I was driving throughout our city recently, something glaring became obvious; at every entrance to our city there are empty buildings that once had a business. Without businesses, more and more of the burden of taxing are falling on homeowners. If this trend continues, there might come a time where there are no businesses in our city, and then ALL of the burden will fall on the residents.

Our city has a large population of seniors and there are fewer families with children moving or staying here. Our population is on a constant decline. As I have reviewed former budget messages from former mayors, this message has been made clear for years. We are now at the point of no-return regarding non-homestead tax levies and business retention and recruiting. As more businesses leave, the greater the shortfall of our bottom line. As I have had conversations with all the members of the City Council over the years, all of us have acknowledged this rapidly growing and obvious problem.

As I and my staff struggle to find solutions for this budget, I have reached out for advice and guidance from the City of Buffalo, particularly, Comptroller Mark Schroeder, as well as West Seneca Supervisor Shelia Meaghan and Cheektowaga Supervisor Mary Holtz. Their information was incredibly helpful and I truly appreciate their help, support, and assistance.

As this budget is presented to you, I am still exploring avenues to address the current shortfall and will continue to explore, throughout the year, all avenues for a more financially vibrant city.
