This is to certify that the Commissioner – Highways has jurisdiction of the highways of the County of Erie and does hereby restrict that portion of the highway in the Town of Hamburg, Orchard Park, and City of Lackawanna said County, known as Erie, and described as follows:

Restriction:

The portion of Abbott Road (CR-4) from Milestrip Road to Fisher Road will have multiple lane restrictions/lane shifts including long term lane closures. These restrictions will be from June 17 with an estimated completion of November 29 or until complete. These restrictions are for the purpose of roadway rehabilitation. Access will be maintained to all traffic. D&H Excavating will be performing the work.

A restriction is executed under Article V, Section 104A of the Highway Law in order to permit a proper completion of work of improvement thereon.
