Re: Funding – Replacement of Salt Shed

On January 9, 2024, there was a wind storm that resulted in the destruction of the City salt shed. The structure was unsafe and could not be rebuilt on the existing foundation. Demolition of the structure took place shortly thereafter. The replacement of the salt shed is vital to snow removal efforts.

The replacement of the salt shed will cost a total of \$274,500.00. An insurance claim was put in for the salt shed resulting in a payment of \$97,528.80. This check is to be deposited in budget line A.5132.0443 City Garage — Repairs and Replacements. Once construction is completed, we will receive another payment from the insurance company in the amount of \$26,524.80 to also be deposited into budget line A.5132.0443 City Garage — Repairs and Replacements. The full insurance payout for the repairs total \$124,053.60.

For the remaining balance, we are asking the council to approve the transfer of \$150,446.40 from A1900.1990 Contingent Account to A.5132.0443 City Garage – Repairs and Replacements.
