3. <u>Mayor Iafallo</u>—Requests the City Council approve her and Councilman Surdyke to attend the New York State Fall Conference of Mayors. It is being held in Saratoga Springs from September 16th through September 20th, 2024.

- 4. <u>City Attorney</u> Requests the City Council approve the ordinance regarding compliance orders with the Code Enforcement Department.
 - 4(A) An ordinance amending Chapter 75 of the Building Code authorizing the Code Enforcement Officers to issue a compliance order in writing to remedy any condition or activity found to exist in violation of the uniform code, energy code or Chapter 75 of the building code.
- 5. <u>City Attorney</u> Advises the Council regarding the name change of the Seasonal Rec Attendants to the title of Playground Watcher for the 2024/25 budget year. On July 30, 2024, Civil Service changed the title of the seasonal Rec Attendant to Playground Watcher.
- 6. <u>City Attorney</u> Requests the City Council approve the proposed Fire Chief Contract for August 1, 2024 through December 31, 2027 and authorize Mayor to execute same.
- 7. **Fire Chief** Requests the City Council approve the request to advertise for bids for confined space fire equipment and direct the City Clerk to advertise for bids.
- 8. <u>Department of Purchasing</u> Requests the City Council approve the ordinance transferring funds between different Development accounts from the 2023-2024 budget line for the replacement of a 2nd Code Enforcement vehicle that is beyond repair.
 - 8(A) An ordinance amending the 2023-2024 Budget Ordinances transferring funds from A.3620.444 "Grant Matches" in the amount of \$15,000.00; A.3620.466 "Demolition of Buildings" in the amount of \$24,995.00; to budget line A.3620.250 "Code Enforcement Vehicle" totaling \$39,995.00.

- 9. <u>Department of Purchasing</u> Requests the City Council approve the agreement with CivicPlus for their Mass Notification System. This will replace the Code Red System which will end on September 2, 2024. The CivicPlus System is \$3000 less than the current system. CivicPlus is also NYS contract pricing.
- 10. <u>Director of Development, Marketing & Public Information</u> Requests the City Council approve the amendment of Alliance Drive land sale to Empire Building Diagnostics. This modification revises the original sale parameters approved on September 25, 2023.
- 11. <u>Director of Public Safety</u> Requests the City Council approve the sale of a 2021 Ford Police Interceptor Utility vehicle. Proceeds will be placed in the Police Operating Budget.

 - 12(A) A resolution for the Library Construction Grant to replace boilers in the amount of \$31,660 and a hot water heater in the amount of \$1,925. Total cost is \$33,585.
