Mr. Georges explained he has work in other shops and has a customer base. It's going to be a small business no high turn around. We do engine work with a 2 to 4 week turnaround time. There will only be two employees myself and Calvin and I am proposing to be open 5 days a week. The hours are 10 to 6 and weekends we will be there but not open to the public. There are concerns from Code and Fire about storing vehicles. We went out got some quotes and depending if we are approve I will have them installed to bring the building up to Code. I paid for rezoning it.

Member Skulski ask about someone working at a dealership and what dealership

Mr. Georges replied yes, my partner Calvin at the North Town Dealership and I also use to work there.

Member Skulski said he is leaving

Mr. Georges no, not until we get this established

Chairwoman Galanti stated you have four lifts inside the building and you are doing major engine changes

Mr. Georges said I do internal engine work such as removing the engine and replacing what needs to be replaced and put it back together, install it back in the car.

Chairwoman Galanti ask what kind of turnaround is it like a one day

Mr. Georges said 2 to 4 weeks

Chairwoman Galanti said are you going to keep the cars that are in process in the building

Mr. Georges replied yes in the building due to hard pull out and security

Discuss the areas of the building

Member Spahn ask how many vehicles will be stored outside

Mr. Georges said right now his own vehicle and maybe a race trailer at some point. It's just me and the employees or someone dropping off parts. I prefer cars inside under lock.

The fire alarm system also has security, so if someone breaks in we have cameras and the alarm system will notify the Police.

Mr. Hayes explained that Mr. Georges has bids as per the Fire Marshal request

Chairwoman Galanti ask about the fire walls

Mr. Hayes said yes there are firewalls

Chairwoman Galanti ask how many vehicles will be stored

Mr. Georges said 10 and 4 lifts and the Fire Marshal wants the man door open in case of a fire.

Mr. Georges stated he does have insurance and no dealers' license

Member Skulski ask about NYS Repair License

Mr. Georges said it depends on this out come

Member Spahn ask are the spaces for your business

Mr. Georges said the landlord set it up with 4 spaces in the front and 4 across from the building
