Approval to Hold Public Meeting – Historic Property Overlay District / OLV Complex

For the January 6, 2025 City Council meeting agenda, I'm requesting your honorable body's approval to hold a public meeting on Tuesday, January 28, 2025 at 5:00 p.m. in Council Chambers regarding creation of a Historic Property Overlay (HPO) district for the Our Lady of Victory Roman Catholic Basilica Complex (OLV Complex)

On February 26, 2024 the OLV Complex was officially listed on the National Register of Historic Places. While this designation is very prestigious, it does not supersede local zoning and planning code. Therefore, with concurrence from Mayor lafallo and a recommendation from the city's Planning & Development Board, the Department of Development is taking the added step of creating this HPO District with guidance from C&S Companies (administrator of the city's Zoning Code Update Project).

The HPO District will work within the context of the city's existing (and future) Central Business District zoning requirements for this area to provide <u>additional protections</u> to buildings, properties, and features that are deemed architecturally and/or culturally significant to the City of Lackawanna. Any development planned for within the HPO District would need to conform to the style of existing buildings and features on the OLV Complex and other buildings and features within the district.

The requested January 28th public meeting is the first of several steps necessary to complete all requirements for creating the HPO District in compliance with SEQR – culminating in a final recommendation for City Council approval sometime in March/April 2025 timeframe. Thank you for your consideration.
