Honorable Members of City Council:

I am requesting changes in fees to various city owned fields and parks as outlines below.

- 1. No Glass containers of any kind allowed at all City parks, playgrounds and fields.
- 2. Require a cleaning deposit of \$50.00 for all shelter rentals which will be refunded if shelter is left in acceptable condition. Increase the shelter rental fee at Galanti park to \$125.00 for residents for the front shelter and \$75.00 for the back shelter, with half off to City employees. Create a non-resident fee of \$175.00 for the front shelter and \$125.00 for the back shelter with preference of availability to City residents first.
- 3. Veterans Stadium will be unavailable this year dUe to the ongoing lighting project. Therefore, we propose keeping our City run league fees the same this year. We would like to increase the league fees for our City run softball and kickball programs to \$200 per team and \$25 per non-resident team member starting with the 2026 season.
- 4. Create a new fee schedule for rental of City Athletic fields, Veterans Stadium, Memorial Field, Avery, etc. for leagues not run by the City. After comparing fees charged by other municipalities for the rental of fields, etc. we have determined that a rental fee of \$1,250.00

would be appropriate for the maintain of our fields. We would also require proof of insurance with the City of Lackawanna listed.
