Surdyke, Council member of the Fourth Ward, is hereby selected and appointed to be Council President Pro-Tempore for the year 2026.
- (B) Resolution #2, whereas Chapter 3, Section 3.7 of the Charter of the City of Lackawanna provides for the meeting dates of the Lackawanna City Council; and the City Council is desirous of complying with the Charter of the City of Lackawanna and Open Meetings Law of the State of New York; the City Council has established the meeting dates for 2026 as per the dates listed on the attached resolution.

(C) Resolution #3, whereas Chapter 3, Section 3.7 of the Charter of the City of Lackawanna designates a newspaper having circulation within the City to serve as the “Official Newspaper” of the City; it is hereby resolved that Buffalo Business First, 465 Main Street, Suite #100, Buffalo, NY 14203, is designated as the official newspaper of the City of Lackawanna for the year 2026.
